Tuition Policy for Honorably Discharged Veteran Exception Tuition and residency classification policy for Arizona's three state universities (The University of Arizona, Arizona State University and Northern Arizona University) is set by the Arizona Board of Regents as authorized by the Arizona State Legislature. The general rule for resident classification for tuition purposes includes evidence of 12 months continued physical presence with concurrent permanent intent to be a resident of Arizona. If however, a student can demonstrate the following conditions they may be eligible for an Arizona residency classification for tuition purposes without meeting the one-year durational requirement:					
1) In the term noted on this form, the student will use the Chapter 30 Montgomery GI Bill Active Duty (MGIB-AD) or the Chapter 33 or Fry Post-9/11 GI Bill at this institution, AND					
2) The student lives in Arizona, AND					
3) The student is enrolled within 3 years of the benefit holder's discharge or death in the line of duty from a period of active duty service of 90 days or more.
