### Non-Resident Tuition Rate Policy for Arizona High School Graduates

If a student can demonstrate **all of the following conditions** they may be eligible for a non-resident tuition rate of 150% of **undergraduate** resident tuition. This rate does not apply to differential tuition, or tuition for on-line, accelerated or distributed programs.

- 1) The student is *not* eligible for in-state tuition, and
- 2) The student has attended high school (grades 9-12) in Arizona for a minimum of three years while physically present in Arizona and graduated from an Arizona high school (or attained the equivalent while physically present in Arizona for a minimum of three years), and
- 3) The student is lawfully present in Arizona, and
- 4) The student is an undergraduate, and
- 5) The student is in a program that charges non-resident tuition

**Note: The 150% tuition rate cannot be combined with UA Merit Scholarships.**
