Tuition Policy for Students with an Arizona Resident Spouse

Tuition and residency classification policy for Arizona's three state universities (The University of Arizona, Arizona State University and Northern Arizona University) is set by the Arizona Board of Regents as authorized by the Arizona State Legislature. The general rule for resident classification for tuition purposes includes evidence of 12 months continued physical presence with concurrent permanent intent to be a resident of Arizona. If however, a student can demonstrate **all of the following conditions** they may be eligible for an Arizona residency classification for tuition purposes without meeting the one-year duration requirement:

- 1) the student is domiciled in this state, AND
- 2) the student's spouse has established domicile in this state for at least one year immediately preceding the last day of registration and has demonstrated **financial independence**, AND
- 3) the student's spouse is entitled to claim the person as an exemption for federal and state tax purposes.
