Tuition Policy for Teacher on Contract

Tuition and residency classification policy for Arizona's three state universities (The University of Arizona, Arizona State University and Northern Arizona University) is set by the Arizona Board of Regents as authorized by the Arizona State Legislature. The general rule for resident classification for tuition purposes includes evidence of 12 months continued physical presence with concurrent permanent intent to be a resident of Arizona. If however, the person is domiciled in Arizona and an employee of a public school district in this state and is under contract to teach on a full-time basis, or is employed as a full-time noncertified classroom aide at a public school within that school district. For purposes of this paragraph, the person is eligible to pay in-state tuition only for courses necessary to complete the requirements for certification by the State Board of Education to teach in a public school district in this state. No member of the person's family is eligible for classification as an in-state student pursuant to this paragraph, although they may qualify under other exceptions.

- Proof of employment status – copy of teaching contract from the school district
- Copy of the Department of Education Report of courses required for certification
- Copy of Arizona driver's license
- Copy of Arizona vehicle registration

- Copy of Resident Alien Card, if applicable
