### Non-Resident Tuition Rate Policy for Arizona High School Graduates

If a student can demonstrate **all of the following conditions** they may be eligible for a non-resident tuition rate of 150% of **undergraduate** resident tuition. This rate does not apply to differential tuition, or tuition for on-line, accelerated or distributed programs.

- 1) Student is an Undergraduate.
- 2) Student is not eligible for resident tuition status.
- 3) Student has attended high school in Arizona for a minimum of three years while physically present in Arizona (the three years of Arizona high school attendance do not need to be consecutive).
- 4) Student graduated from an Arizona high school (or attained the equivalent while physically present in Arizona for a minimum of three years).

**Note: The 150% tuition rate cannot be combined with UA Merit Scholarships.**
