





Streamlining University Registrar Processes to Amplify Student Success

SURPASS eForms

- These forms can securely pull user information directly from PeopleSoft (UAccess), drastically cutting down on the need for data entry on either end of the process
- Users can, if necessary, save their progress on a \bullet request in UAccess Student Center and return to it at a later time
- The forms also support multiple approval routing options and allow approvers to approve, deny, even "recycle" forms back to students to be updated and resubmitted







You Asked... We Answer!

- 1. What should students do to troubleshoot if it has been a long time, and their transfer credit is not been added to their record? Is there anything Advisors can do to help troubleshoot? - Amanda Gluski
- 2. No 'Change of College Form' exists, and this results in confused students emailing college deans to request a change of major. How can we get language updated in the Change of Major section on the General Catalog? - Abbie Sorg
- 3. Can we please make GROs automatic? Or can we let Advisors submit GRO requests for students? Even if an advisor could submit the request when a student confirms they want to use a GRO, that would be a huge help. Students often say they will GRO in a meeting or phone call, and they want/mean to, but many never take the steps to actually submit their request to GRO. -Michael Davenport
- 4. Is an update mechanism possible for GRO, so students can register to use it before the class begins? - Michael Davenport

- 5. Regarding the 18 Unit, W-Limit Status: Rumor has it this policy update is moving through the pipeline; do we have an idea when this might get formally approved and be a reality for students? Are we hoping this will get adopted starting Summer 2023 or Fall 2023? – Abbie Sorg/Michel Davenport
- 6. When are non-medical General Petitions going online? Is there a way for Colleges to potentially "fast track" certain General Petitions for Retroactive Complete Withdrawal for approval? - Michael Davenport
- 7. Can some of the UAccess language about DAW reminders to book advising appointment with your advisor be updated or removed? -Amanda Gluski
- 8. We have been hearing that a new online process would be implemented for Degree Audit Worksheets (DAWs) since before the pandemic, but I haven't heard anything about them recently. Is this still in the works? If yes, any ETA? – Amanda Gluski



You Asked... We Answer!

- 9. Regarding Pass/Fail Rules, Currently, students must a sophomore in standing and also must be in 12 graded units. Students are already pretty limited in what they can P/F, as P/F can't be used for degree requirements (only electives) and most classes don't have the P/F option. [Overwhelmingly the courses students P/F are Spanish classes leading up to their language requirement. Many students doing this may not be sophomores, as you typically start language in the first year. It's also unusual for a student to be in 12 graded units in the summer, if they are taking Spanish over the summer (also common).] This restriction blocks students who have a legitimate reason to P/F, and there's already such a limited opportunity to P/F, that this additional sophomore standing/12 graded units seems overly burdensome. -Abbie
- 10. Regarding repeat credit, Can students simply get blocked entirely from registering for classes they have previously earned an A or a B in? If there are necessary exceptions, advisors could approve these individually through the same form used to allow repeated credit above three attempts (Historical Exceptions to Course Repeat Policy form). – Alex/Michael/Amanda
