
CHECKLIST for USING YOUR VA BENEFITS FOR GLOBAL STUDIES / STUDY ABROAD

I understand the following VA regulations must be met in order to use my GI Bill for a study abroad program as a student earning a degree at UA:

- All of my class enrollment from this program will appear on my official UA transcript as UA coursework factoring into my UA GPA. (Units will not transfer in from the other institution--**the VA will only pay for courses that apply to the student's degree and offer UA direct credit**. These programs can be found on the Global Initiatives website <https://global.arizona.edu/study-abroad/direct-credit>.)
- I understand that if I am using the Post 9/11 (Chapter 33) GI Bill **the VA will only pay for TUITION up to what I would be charged if attending UA**. I understand that the VA will **not** pay for housing, travel, meals, and miscellaneous fees, etc.
- I understand that all other benefits are paid on a monthly basis directly to me (the student) as if I were attending here at the U of A. I have read the Post 911 Study Abroad Factsheet and understand what the VA will not pay for

- I understand that each individual class that I apply to my VA certification must also apply to my UA degree and the UA will remain my "parent" school for the term (a parent school is the school that awards the degree).
- I confirm that the program I will complete at the school I will attend is listed as approved by the VA <http://inquiry.vba.va.gov/weamspub/buildSearchCountryCriteria.do> (search by school name and country and then Programs to view a Description of approved programs.)

- I have attached to this document a completed Approval for Global Studies / Study Abroad Credit form (page 2 of this document). My UA advisor has signed this form verifying that the courses I am taking are going towards my degree.
- The classes I will complete will appear on my UAccess schedule either individually as listed on the approval form or with Study Abroad Placeholder Registration units totaling the number of units I will complete.
- I have verified with my Study Abroad advisor that the class start/end dates for my Study Abroad classes are correct as listed on my approval form.
